ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS

- 2. I acknowledge that motorcycle sport is dangerous and that by engaging in the sport and participating in the meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
 - (a) that I may be injured, physically or mentally, and may be killed.
 - (b) that my machinery or equipment may be damaged, lost or destroyed
 - (c) that other competitors may ride dangerously or with lack of skill
 - (d) that track or event conditions may be hazardous and may vary without warning or predictability
 - (e) that organisers, officials, landowners and agents or representatives of those in charge of the meeting are frequently obliged to make decisions under pressure of time and / or events.
 - (f) That any policy of insurance of or in respect of my life or physical or mental health may be voided
 - (g) That there may be no or inadequate facilities of treatment or transport of me if I am injured
 - (h) That I have an obligation to myself and others to compete safely and within the rules of competition
